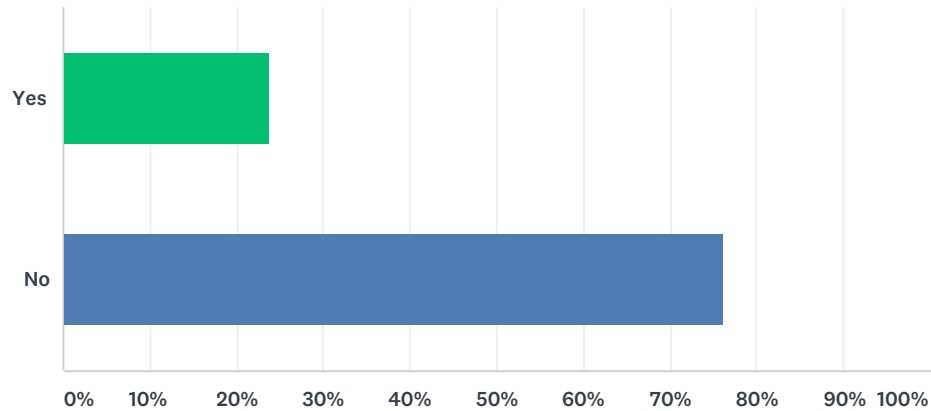


Q1 Do you want historic designation for Burleith?

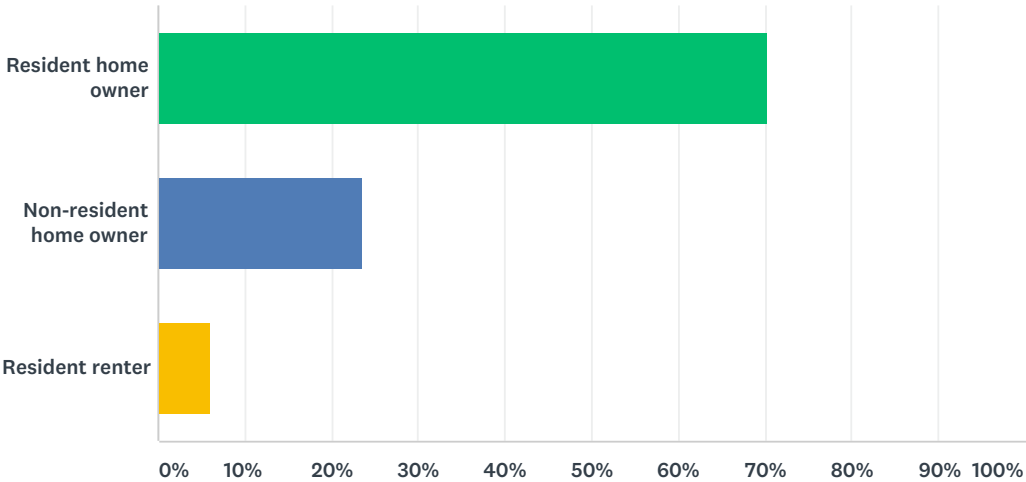

Q2 How are you affiliated with Burleith?

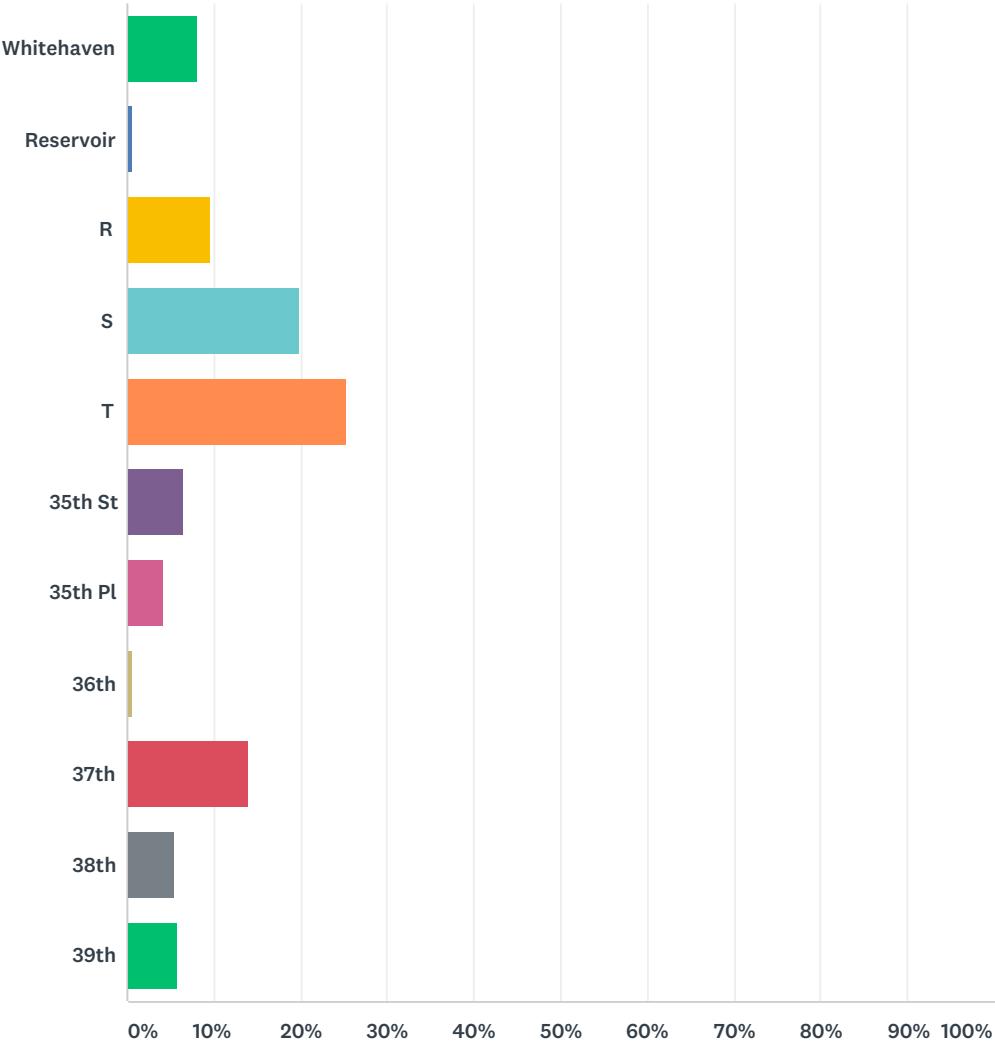

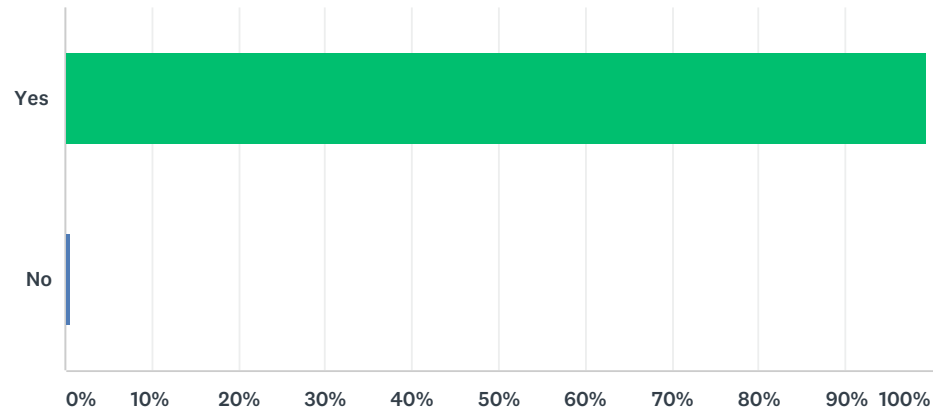

Q6 Are you 18 years of age or older?

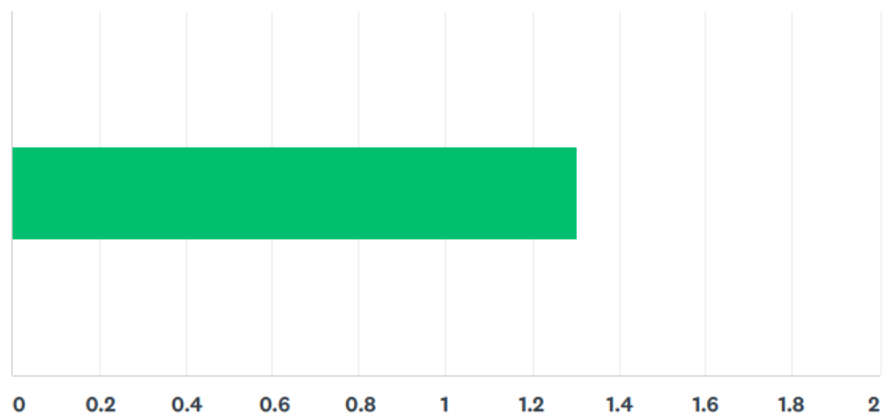

Q7 How many homes do you own in Burleith?

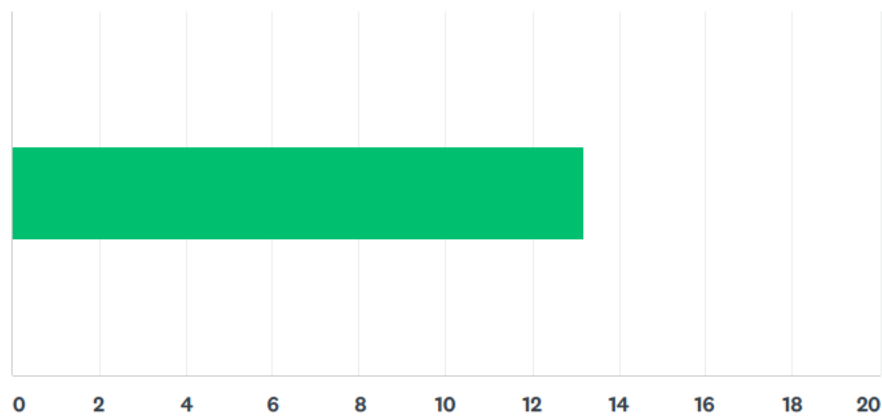

Q8 How many years have you lived in Burleith?

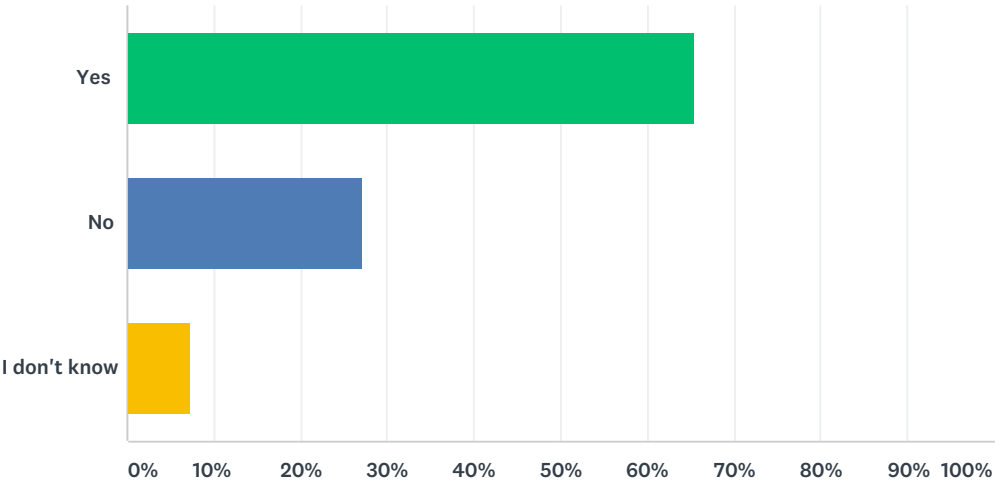

We own a house in Georgetown which has a historic designation. It is impossible to do anything to the house including basic upkeep. There is no reason we should be discussing this especially since much of our neighborhood is sinking. Can only imagine the impact a historic

designation would have on trying to stabilize a foundation. We have enough work to do to keep the neighborhood looking good so we shouldn't be limiting the home owners with future upgrades.

To explain the zero on years, we moved in [REDACTED] months ago. We would gladly join the citizens association.

Burleith's historic charm and character--the adorable Colonial face-like facades, the beautiful old foliage, the brick sidewalks of R street--these are the reasons I fell in love with the neighborhood and wanted to buy our house specifically. I firmly believe our neighborhood is one of the most beautiful in the District. However, I also believe strongly that every homeowner should have the right to upgrade, update, renovate, restore and rebuild their home to maintain the incredible trends of 1) increasing home values and 2) younger families moving into Burleith. We recently moved out of the house, but plan to move back in once children are older

We have lived in Burleith for [REDACTED] years. We sold our first house because it could not be added on to accommodate our [REDACTED] children. We moved to a larger home that we are now purchasing. We feel strongly against historic designation. Young families do not want to invest in home that

can't be enlarged and easily renovated. We are happy with most of the renovations that have occurred over the past several years. We think the neighborhood needs updating on most of the blocks in Burleith.

I am concerned that HD will increase the cost and time for homeowners to renovate.

I don't mind variety in the look of the Burleith homes, but do object to renovations which effect neighbors negatively. I would urge the BCA to alert us to building applications which call for extensions up and/or back [REDACTED] which surely are beyond normally allowable limits.

Financially it makes no sense to limit renovations to the historic designation. I want to upgrade my home and be a member of the community for many years to come. If the designation is passed I will have to move within the next few years...

I am very happy living here in Burleith. I hope this will continue, but am worried very much about whether the homes attached on either side of me will build up and/or out on their homes. I am concerned that I will no longer go outside in the back of my home, because of extended living spaces on either side of me which would most certainly reduce the amount of light I receive and enjoy in the morning and all day and evening. I am also deeply concerned about losing private enjoyment in my backyard spaces due to loss of privacy, i.e. windows facing my patio or backyard, which I unfortunately have to deal with now, because of additional windows on a pop-up and extension further back which face my back deck. I would definitely be for historical designation in order to preserve the privacy, light, and also maintain the breezy airflow still possible to enjoy. I feel our neighborhood still offers these things for the most part, and I would like to continue enjoying these conditions of living.

Most houses that have been recently renovated are nice. They attract new families with young children. This is clearly a plus for Burleith. Historic designation would slow the pace of renovation, and Burleith would be stuck with a stock of houses in need of a serious upgrade.

My son resides at the [REDACTED] property and I visit often.

I value Burleith's close-knit neighborhood, its townhouse style, the location, the trees and gardens, and general charm. But i think there are other ways to maintain the things of value (including light and air) by using traditional planning tools, rather than historic designation.

I wish there were strictly enforced zoning code and am angry that there isn't. HD is too restrictive, but the status quo is unacceptable as well, so this was a tough choice for me. It also is, or ought to be, a false choice. This should not be our only option!

I presently live in [REDACTED] and plan on moving back to [REDACTED] soon. [REDACTED] has become too noisy and with helicopters permitted at GW Hospital it will be unlivable.

I am a member of the BCA but do not have any voting rights because the house I own is under an LLC. I don't think that I should be denied voting rights due to my decision to own the property under a legal entity. I should have every right as any other owner in Burleigh and I think it's not fair to exclude me from the future of our neighborhood.

We are [REDACTED] who grew up in Burleigh and recently purchased a home here, but have not moved here yet.

It's refreshing that some neighborhoods can grow and change in look and are not frozen in time. Not all areas are worthy of protection especially the unremarkable 1930s properties of Burleigh. Whatever happened to a city growing and changing. Density should be encouraged in the city. This is simply an anti Development ploy by a few neighbors and does not at all represent the overall owner pool.

I lived in this house as a child and as a young adult. It is currently a rental.

I fear my membership has lapsed. I was a member for many years.

I grew up in Burleigh on [REDACTED] I recognize that development is changing the face of the whole city, not just Burleigh. But living styles are driving this growth. Zoning and overlays are important. Historic Designation strips owner's of their individual rights, and is not the answer here.

I know there is a group who is interested in HD, and they have valid reasons for their views; but, I hope this survey finally brings an end to this issue. With all the divisive viewpoints, I can't imagine what the process would look like to actually write the rules and regulations required for HD. Being that it's taken years to simply vote on the concept, it may be decades before the regulations could be agreed to. Are the pro-HD group really up for that fight? Does having a say on what their neighbors can/cannot do to their own property really mean that much to them? This neighborhood is in a time of transition - right now. By the time HD could be implemented, would it even matter?

Go for it!

I hope this survey is fair and the total results are published with information that assures us the results are accurate and totally transparent.

To further analyze the different viewpoints on historic designation (HD) this survey should have contained additional questions asking respondents: (1) their occupation and (2) whether their interest in Burlieth homes is residential and/or commercial. As a resident homeowner, I have recently received a lot of correspondence from realtors trying to influence me to oppose HD. I can't help feeling like their lobbying effort is self-serving. They may fear that they will sell fewer homes or have fewer bidding wars (and, thus, lower commissions) as a result. I also think that homeowners who are renting out their entire homes or conducting other business activities are essentially running a commercial enterprise and that their responses should, therefore, be tabulated separately. A newly renovated pop-up house on my block is being operated as conference center/meeting space, so naturally I would expect the owner to oppose HD.

Historic designation would be a huge mistake. Please do not let this happen.

Believe the market and zoning are appropriate influences on renovation. And any historical value has already been lost given the home renovations completed and in progress (most resulting in improved structures vs. the many dilapidated houses that were replaced or renovated).

Historical designation just means that only people with money for lawyers can do work.

Strong emphasis on additions not being visible from the sidewalk. Focus on rear of houses as a starting point

the BCA has done a great job of making the neighbors fully aware of the HD issues and giving everyone an opportunity to be heard.

I presently rent the house on [REDACTED] however I presently live a few blocks away in [REDACTED] - consequently I still share many of the concerns about development

The neighborhood is doing a good job keeping their arms around fixing up properties and building out (and up) homes. There is a lot of work still to do to update some of the homes...still a lot of foundation issues on certain streets and I feel that putting a historic designation on the neighborhood will handcuff the owners both short-term and long term. I think the first question is unfortunately worded since the question at hand is not whether Burleith will get Historic Designation, but rather whether the BCA should apply for the city to consider it. At a minimum, the first question should have had a third button "undecided" or "uncertain" added to the possible responses.

Please note that I was on the Burleith Citizens Association for several years. I also assisted in the formation & Form IRS-1023 application for 501 (c) (3) status for the BCF.

We are just moving in, bought the house this spring.

My answer is NO simply because of the toxic nature of the conversation surrounding HD/no HD. It's disappointing that everyone who subscribes to the listserv---intended to be a neighborly exchange of info or goods or ideas---has to be subjected to the daily, hit-below-the-gut back and forth rants on this topic, seemingly from the same relatively small handful of residents. While I can appreciate their passion, the line of appropriateness or decorum has long since been crossed. Individual homes were cited and critiqued as examples--homes that in some cases were purchased by new neighbors we should be welcoming to the neighborhood vs making them question their neighborhood choice. Some neighbors were singled out and accused of personally benefiting from voting non-HD, with no apparent factual basis. Therefore I'm saying "enough is enough" with my answer above. I also chose to not renew my BCA membership this year, for this exact reason.

I regret to say that I think we are past the time for an effective and non-confrontational implementation of HD in Burleith. The appearance of the neighborhood has changed dramatically over the past several years, and it is continuing to change rather rapidly. Given that HD takes several years to take effect, Burleith will have then undergone an altered appearance that I believe will not be affected by the implementation of HD.

I strongly oppose Burleith becoming historically designated.
